## Patient Privacy & Security

SacValley MedShare follows all the same state and federal HIPPA privacy regulations as your local doctors and hospitals.

Your providers already share patient information necessary to provide safe and timely care. Phone calls, faxes, and postal mail are not the fastest nor safest methods for communicating.

SacValley allows your doctors to send and receive information quickly and securely.

SacValley MedShare doesn't access any patient information. SacValley never sells patient information.



## How Does a Health Information Exchange (HIE) Help?

Most healthcare organizations are closed evenings, weekends and holidays. SacValley MedShare allows doctors to access information 24 hours a day, 365 days a year.

Many northern Californians travel large distances for personal and professional reasons. Emergencies can happen far away from your primary care and medical records.

Patients have better outcomes when specialists and primary care physicians communicate. Sharing test results, coordinating care, and providing timely feedback improves the quality of care.
